Risk assessment and management in mental health is recognised worldwide as a significant clinical issue in our times

Risk Management is an integral and complex part of professional health practice. It is argued that the complexity of mental health risk assessment and management requires further research and discussion in an interdisciplinary environment. The complexity of mental health related concerns in both society and professional practice is central for mental health practitioners being able to negotiate and communicate risk.

This symposium will contemplate critical themes, debates and opportunities for shared learning related to risk for people with mental health problems and mental illness. The Symposium will highlight interventions using clinical practice, illustrative case studies and research experiences from practitioners. During the presentations and discussions, particular attention will be given to learning in practice. Each presenter will explain how practice experience can contribute to deeper understanding of risk assessment and management in mental health. The presentations from SA Health clinicians will focus on metropolitan and country health settings, adult and older persons' contexts. These will be supplemented by key note addresses from invited external speakers.

The **Acute Unit Matters** initiative is part of SA Health Operations. The initiative aims to strengthen the capacity of the acute sector of State mental health services to provide care and treatment to those consumers who are most unwell. At its inception in August 2009, the Acute Unit Matters initiative set "Seven acute priorities" or areas of focus. Four of these have particular relevance to Risk Assessment and Risk Management:

- Induction, Capability and Competency building and strengthening the complex skills set required of staff within a modern-day acute mental health setting.
- Assessment and Care Planning ensuring that the assessment of a consumer's needs is reflected in a treatment or management plan which everyone involved can understand and access.
- "Stepping Down and Stepping Up" providing the right level of care or treatment "at the right time", when a person needs it most.
- Working with Co-morbidities Initiating and supporting consistent approaches to co-morbidity assessments and brief interventions within the acute inpatient setting, in relation to drug and alcohol, intellectual disability and physical health needs.
