Presenters: Associate Professor Brigid Daniel, Professor of Child Care and Protection, University of Dundee, Scotland.

Professor Brigid Daniel studied Psychology at St Andrews University and went on to carry out a PhD in Psychology at Edinburgh University. She spent a year as a post-doctoral research fellow before training as a social worker, also at Edinburgh University. She worked for some years in local authority social work in Edinburgh. She then moved to the University of Dundee to teach on the post-qualifying Child Protection Courses run by the Social Work Department.
