Conditions of Acceptance

Tuition fee change

If there is any change in tuition fees between the date of this Offer and the date the University receives my tuition fee payment, the University reserves the right to adjust the tuition fees for the program. The tuition fees may change if I decide to defer my enrolment. I must pay the University the changed tuition fees before enrolment. If I commence a new program in 2012 and beyond I am aware that annual tuition fees may increase for each year of study. I am aware that in the event of a variation between the fees on this offer letter and the approved University schedule of tuition fees found at <http://programs.unisa.edu.au/public/pcms/>, the approved University schedule will prevail.

The University's responsibilities with a change of Offer

The University reserves the right to:

- withdraw an Offer if I do not meet the conditions specified in my Offer of Admission;
- withdraw an Offer if the University does not receive the tuition fees and the completed and signed Acceptance and Payment Form from me before the program places are all filled;
- verify the documents provided with the application and withdraw an Offer if they prove to be fraudulent in any way;
- alter the Guidelines on Payment and Refund of Fees for International Students to reflect any changes in tuition fee setting or fee refund policy which may occur from time to time.

NOTE: Australian statutory authorities external to the University reserve the right to change conditions of professional registration (e.g. nurses, teachers) and the information currently provided by the University is therefore subject to change.

Student's responsibilities

I acknowledge and agree that:

- the Offer made by the University relies on the information I have provided to be true and correct and that any false information provided or lack of disclosure may lead to a termination of my enrolment;
- the information collected on this form and during my enrolment is in order for the University to meet its obligations under the ESOS Act and the National Code 2007; to ensure my compliance with the conditions of my visa and my obligations under Australian immigration laws generally. The authority to collect this information is contained in the Education Services for Overseas Students Act 2000, the Education Services for Overseas Students Regulations 2001 and the National Code of Practice for Registration Authorities and Providers of Education and Training to Overseas Students 2007. Information collected about me on this form and during my enrolment can be provided, in certain circumstances, to the Australian Government and designated authorities. In other instances information collected on this form or during my enrolment can be disclosed without my consent where authorised or required by law;
- I give my consent for the University to check my visa status and study entitlements with the Department of Immigration (including via the Visa Entitlement Verification Online (VEVO) Service);
- I give my consent to the University to provide my personal details to my overseas student health care provider for the purpose of creating my overseas health cover policy;
- I will arrive on campus in time for orientation and enrolment and if I arrive after the commencement of classes, I may not be permitted to enrol in the program;
- I am bound by UniSA academic and other policies and procedures relevant to international students including:
 - restriction on transfer to another provider during the first six months of my UniSA program
 - maintenance of enrolment in all study periods to enable completion of the program within the duration specified on my Confirmation of Enrolment document
 - maintenance of satisfactory academic progress and attendance at classes
 - payment of tuition fees in accordance with my invoice due dates
 - initial fees paid will not be accepted without this signed agreement;
- if granted recognition of prior learning (credit/advanced standing) I acknowledge and accept the credit/advanced standing;
- I am responsible for obtaining a visa that permits me to study in Australia for the duration of my program and will abide by the conditions attached to my visa including:
 - notifying UniSA and the Department of Immigration and Citizenship of any change in my address within 7 days
 - maintaining valid health insurance and adhering to its conditions over the period of my student visa



- working no more than 20 hours per week when classes are in progress
- UniSA may report any suspected breaches of my visa conditions to the Department of Immigration and Citizenship and this may result in the cancellation of my student visa;
- if I defer or suspend my program of studies, this may affect my student visa (e.g. it may be cancelled);
- the University may defer or temporarily suspend my enrolment due to misbehaviour and this may affect my student visa (e.g. it may be cancelled);
- I will pay all associated visa costs should compassionate and compelling circumstances require me to extend my program of studies;
- this agreement, and the availability of UniSA complaints and appeals processes, does not remove my right to take action under Australia's consumer protection laws (Section 43, ESOS Act);
