### Introduction – What does my participation involve?

You are invited to participate in a research project exploring experiences in the Emergency Department. This research is being conducted by a team of researchers from the University of South Australia (UniSA), funded by MIND Australia. Participation in this research is voluntary. If you don't wish to take part, you don't have to. This Participant Information Sheet tells you about the research project and explains the processes involved. Knowing what is involved will help you decide if you want to take part in the research.

### What is the purpose of this research?

Psychosocial disability has been included in the National Disability Insurance Scheme (NDIS) since its inception, yet many of the fundamental design features of the scheme were developed without reference to the needs of this population. People with a psychosocial disability may at times become unwell and need emergency care. How this affects their NDIS plan and continuity of care is the aim of this research. People with a psychosocial disability have particular needs within several converging health care systems. To date research has focussed on people with a disability rather than a psychosocial disability and not within the emergency department setting.

### Who is being invited to participate?

Emergency department clinicians, including doctors, nurses, social workers and allied health workers who attend to people with a psychosocial disability NDIS plan presenting to the emergency department and who have done so within the last two years.

### What does participation in this research involve?

You will be invited to participate in a national anonymous online survey which will take between 15 – 25 minutes. Before participating in the survey, you will be asked to read this information sheet, contact the research team to clarify any questions you may have and to acknowledge consent at the beginning of the survey.

### What are the possible benefits of taking part?

We cannot guarantee that you will receive any benefits from this research; however, this research will inform hospital policy makers as to recommended practice and pathways of continuity of care from the experience of emergency department clinicians.

### What are the possible risks and disadvantages of taking part?

The risks are minimal, but nevertheless there is some risk. The online survey is intended to be anonymous. The researcher will take every care to keep data confidential. However, confidentiality of anonymous data stored on the internet survey platform cannot be guaranteed. #### Do I have to take part in this research project?

Participation in any research project is voluntary. If you do not wish to take part, you do not have to. Once you have participated in the anonymous survey you cannot withdraw your responses as they will be anonymous and therefore it will not be possible to identify your particular responses.

As your participation is anonymous your decision whether to take part or not to take part, or to take part and then withdraw, will not affect your relationship with professional staff or your relationship with the University of South Australia.

#### What will happen to information about me?

All anonymous surveys will be stored electronically on a password protected UniSA server, in a locked office at UniSA, City East Campus, and will only be accessed by the research team. The anonymous survey responses will be analysed collectively and not individually. Your information will only be used for the purpose of this research project. Once the project is complete, all electronic and hard copy data will be stored in a locked compactus at UniSA, City East Campus, for five years, after which it will be destroyed.

#### Who has reviewed the research project?

The ethical aspects of this research project have been approved by the Human Research Ethics Committee (HREC) of the University of South Australia as required by the Australian government research requirements, specified in the National Statement on Ethical Conduct in Human Research (2007 - updated 2018). This statement has been developed to protect the interests of people who agree to participate in human research studies.
